6. All the concerned PIU's are directed to submit Utilisation within two weeks in BRRDA.

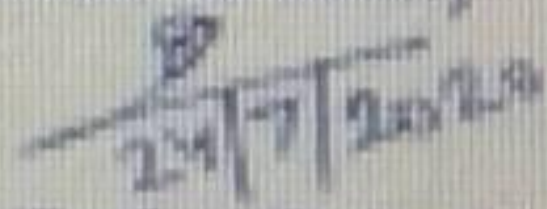
7. If any irregularities in payment will be examined the payment authorities will be held responsible.

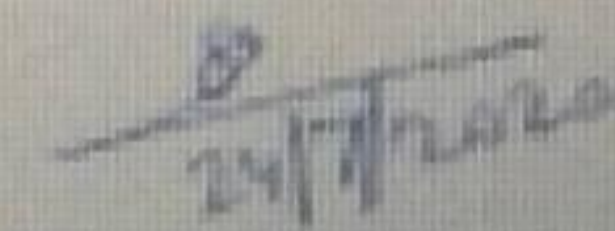
