विषय- वर्ष 2020 के बाढ़ में क्षतिग्रस्त हुये पथों के अस्थायी/स्थायी पुनर्स्थापन हेतु कार्य योजना के संबंध में।

महोदय,

माह जुलाई 2020 में आयी अप्रत्याशित बाढ़ से पूरे राज्य में खासकर उत्तरी बिहार में बृहत पैमाने पर ग्रामीण पथ क्षतिग्रस्त हुए हैं। इनको मोटरेबुल बनाने तथा पूर्ण पुनर्स्थापन का कार्य अतिशीघ्रता से विभाग द्वारा सम्पन्न किया जाना अपेक्षित है ताकि यातायात कम से कम अवधि में बाधित रहे। यह कार्य बिहार विधानसभा के संभावित आसन्न चुनाव के मद्देनजर और भी महत्वपूर्ण हो जाता है। अतः क्षतिग्रस्त हुये पथों की मरम्मती हेतु शीर्ष FDR/MR 3054 के अन्तर्गत एक ठोस कार्य योजना बनाये जाने की आवश्यकता है जिससे कि पथों के Restoration का कार्य शीघ्रतिशीघ्र पूरा किया जा सके।

क्षतिग्रस्त पथों के अस्थायी/स्थायी पुनर्स्थापन हेतु कार्य योजना निम्न प्रकार है जिसके आलोक में सभी संबंधित कार्य प्रमंडल द्वारा-

1. दिनांक 15.09.2020 तक पूरी विवरणी Road Wise, Chainage Wise MIS के FDR Module पर अपलोड कर दिया जायेगा।
2. दिनांक 30.09.2020 तक सभी पथों का अस्थायी मरम्मति कार्य पूर्ण करा दिया जायेगा।
3. दिनांक 31.10.2020 तक असंबद्ध कार्यपालक अभियंता से मोटरेबुल कार्य का शतप्रतिशत जाँच कार्य पूर्ण करा लिया जायेगा। संबंधित अंचल के अधीक्षण अभियंता द्वारा इस आशय का पत्र निर्गत किया जायेगा।
4. दिनांक 15.11.2020 तक Action Taken Report का Uploading MIS पर FDR Mod में पूर्ण करा लिया जायेगा।
5. दिनांक 30.11.2020 तक सभी एकरारनामा अधीन पथों का पूर्ण पुनर्स्थापन कार्य पूर्ण लिया जायेगा। इससे संबंधित विभागीय पत्र सं0 726 दिनांक 12.02.2020 पूर्व में निर्गत है।
6. दिनांक 31.10.2020 तक अनुरक्षण से बाहर के पथों के पूर्ण पुनर्स्थापन का आवश्यकता अनुरक्षण नीति के तहत प्रस्ताव विभाग को समर्पित किया जायेगा।
