A suitable abstract should than be prepared which should collect in the case of measurement for work done the total quantities of each distinct item of work relating to each sanctioned sub-head.

- (e) As all payments for work supplies are based on the quantities recorded in the measurement books it is incumbent upon the person taking the measurement to record the quantities clearly and accurately. If the measurements are taken in connection with a running contract account on which work has been previously measured he is further responsible (1) that reference to the last set of measurements is recorded and (2) that if the entire job or contract has been completed the fact is recorded prominently just above his initials.
- (f) Entries should be record continuously in the measuremen book No blank pages may be left and no page be turn out Any page left in advertently must be cancelled by diagona lines. The cancellation being attested. See also paragrapl or the Public Work Department Code.
- No entry may be erased, of a mistake is made it should be correct (and dated) by the responsible officer in the manner prescribed in paragraph 335 of the Public Works Department Code. When any measurements are cancelled, the cancellation, must be supported by the dated initials of the officer ordering the cancellation or by reference to his orders installed by the officer who made the measurements in either case the reason fo cancellation should be recorded.
