- (g) No entry may be erased, of a mistake is made it should be correct (and dated) by the responsible officer in th manner prescribed in paragraph 335 of the Public Work Department Code. When any measurements ar cancelled, the cancellation, must be supported by the dated initials of the officer ordering the cancellation or b reference to his orders installed by the officer who made e measurements in either case the reason for cellation should be recorded.
