Notice or invocation by any person such as assignee, transferee or agent of beneficiary shall not be entertained by the bank. Any invocation of guarantee can be made only by the beneficiary directly."

- a) Our liability under this Bank Guarantee shall not exceed **Rs. 30,55,000/- (Rupees Thirty Lac Fifty five Thousand Only)**.
