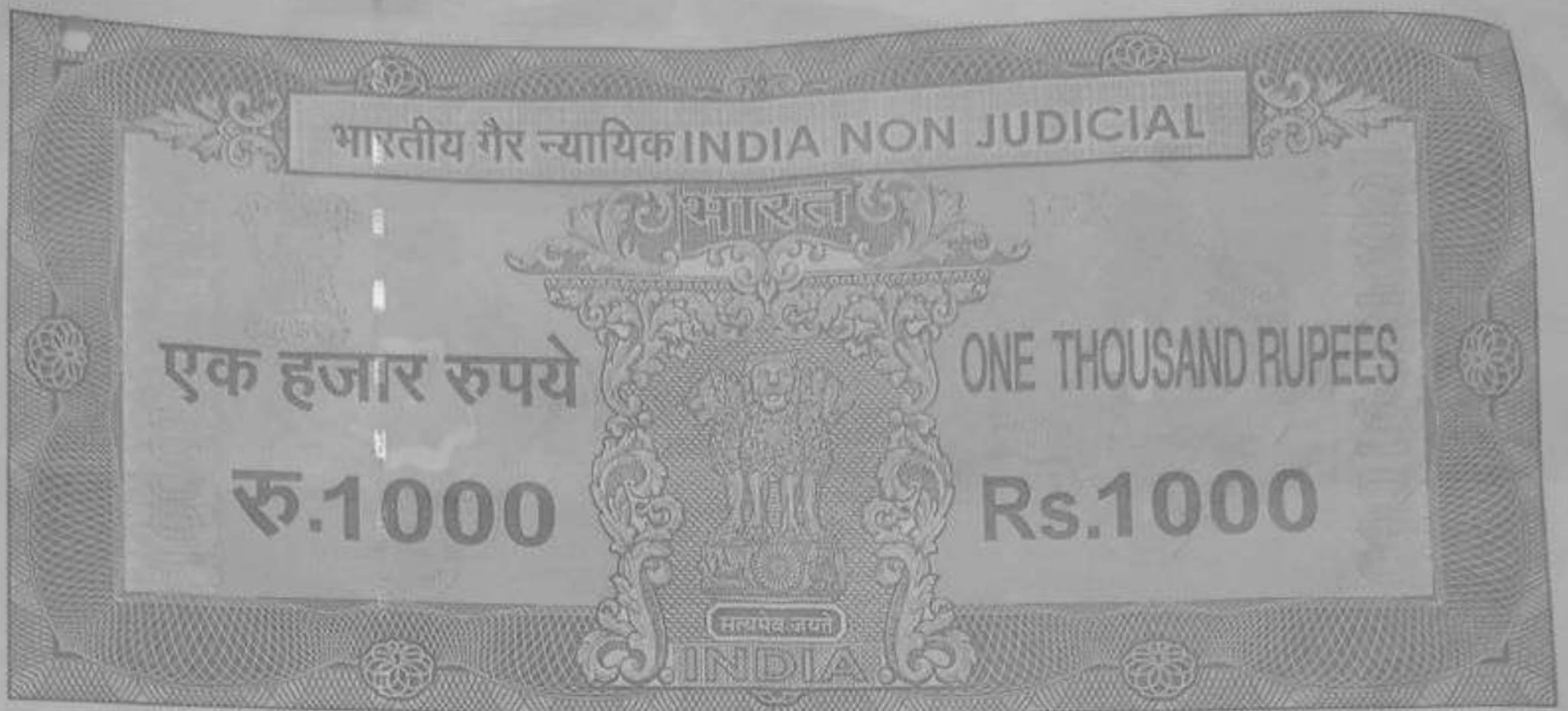

    - i) Letter of Acceptance;
    - ii) Notice to proceed with the works;
    - iii) Contractor's Bid;
    - iv) Contract Data;
    - v) Special Conditions of contract and General Conditions of Contract;
    - vi) Specifications;
    - vii) Drawings;
    - viii) Bill of Quantities; and
    - ix) Any other document listed in the Contract Data as forming part of the contract.
