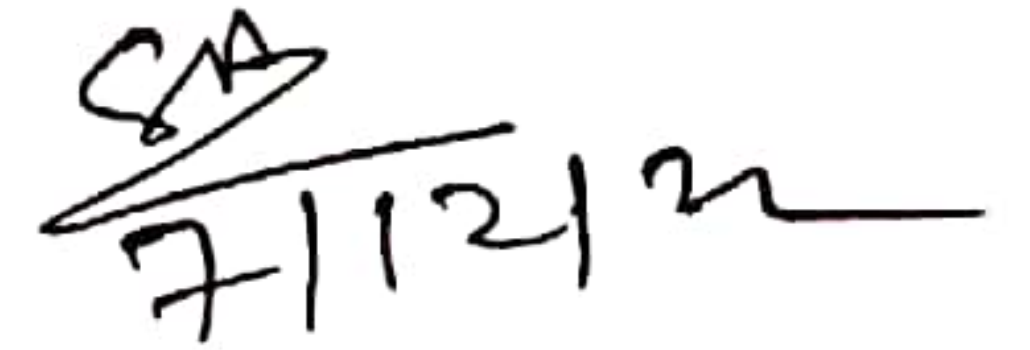

रहा है।

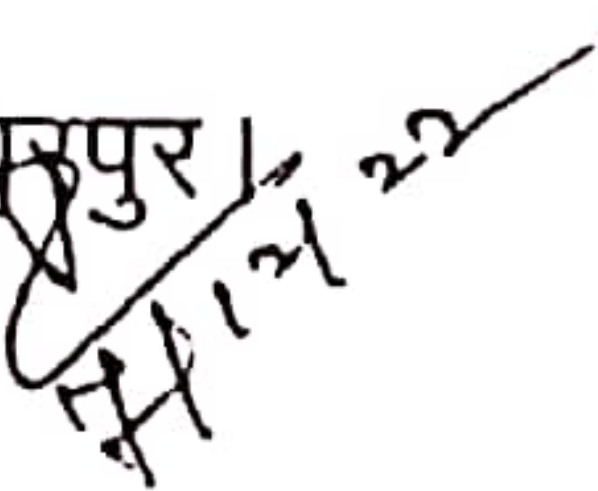
