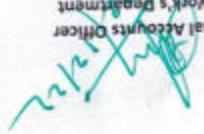

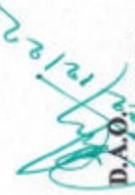

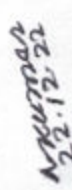
**Kind of Checks exercised:-**
