The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the works and remedying the defects wherein and undertaking routine maintenance for five years, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.

  - (x) Any other documents listed in the Contract Data as forming part of the contract.
