



प्रस्तुत प्राक्कलन, अथमलगोला प्रखण्ड अंतर्गत जयप्रकाश हाल्ट से वरहैया गाँव तक पथ का आपातकालीन मरम्मति हेतु तैयार किया गया है । यह पथ MMGSY (WB) योजनाअंतर्गत स्वीकृत है जो निर्माणाधीन है । इस पथ में पूर्व से 1800सी में GSB ग्रेड II, Stone metal WBM Gr- II एवं stone metal WBM Gr- III करने के पश्चात 1200मी में surface dressing का कार्य भी कराया जा चुका था.

इस वितीय वर्ष 2021-22 में बाद एवम अतिबृष्टि के कारण पथ के एक स्थान पर कटाब हो गया था। साथ ही पथ के विभिन्न स्थानों पर stone metal WBM Gr-III, Surface Dressing एवं फ्लैंक भी काफी स्रतिग्रस्त हो गया है। विभागीय निर्देशानुसार पथ को यातायात योग्य बनाने हेतु पथ के कटाब वाले स्थान पर Brick Bats भर दिया गया। वर्तमान में आवागमन चालू है। पथ को पूर्व की स्थिति में लाने हेतु -पुनर्स्थापना का प्राक्कलन बनाया जा रहा है।



### CONDITIONS OF CONTRACT

Compensations

Clause 1 :- All compensation or other sums of money payable by the contractor to Government under the terms of his contract may be deducted from or paid by the sale of a which may be due or may become due to the contractor by Government on any account what so ever and in the event of his security deposit being reduced by reason of any such deduction or sale as aforesaid, the contractor shall within the days there after make good in cash or Government securities endorsed as aforesaid any sum or sums which may have been deducted from or arise by sale of his security deposit or any part there of.

The work should not be considered finished until such date as the Executive Engineer shall certify as the date on which the work is finished after necessary recitations of defects as pointed by the Executive Engineer or his authorised agents are fully complied with by the contractor to the Executive Engineers satisfaction.

Clause 2:- The time allowed for carrying out the work as entered in the tender shall be strictly observed by the contractor and shall be reckoned from the date on which the written order to commence work is given to the contractor. The work shall throughout the stipulated period of the contract be carried on with all due diligence (time being deemed to be the essence of the contract on the part of the contractor) and the contractor shall pay as compensation an amount equal to percent on the amount of the estimated cost of the whole work as shown by the tender for every day that the work remain uncommenced or unfinished after the proper dates bound in all cases in whiche the time allowed for any work exceeds one month to complete one fourth of the whole of the work before one half of such time elapsed and three fourths of the work before three fourths of such time has elapsed. In the event of the contractor failing to comply with this condition, he shall be liable to pay as compensation an amount equal to 1/2 percent, on he said estimated cost of the whole work for every day that the due quantity work remains incomplete. Provided always that the entire amount of compensation to be paid under the provisions this clause shall not exceed 10 percent on the estimated cost of the work as shown in the tender.
