प्रस्तुत प्राक्कलन, अथमलगोला प्रखण्ड अंतर्गत जयप्रकाश हाल्ट से बरहैया गाँव तक पथ का आपातकालीन मरम्मत हेतु तैयार किया गया है। यह पथ MMGSY (WB) योजना अंतर्गत स्वीकृत है जो निर्माणाधीन है। इस पथ में पूर्व से 1800मी में GSB ग्रेड II, Stone metal WBM Gr-II एवं stone metal WBM Gr-III करने के पश्चात 1200मी में surface dressing का कार्य भी कराया जा चुका था।

इस वित्तीय वर्ष 2021-22 में बाढ़ एवम अतिवृष्टि के कारण पथ के एक स्थान पर कटाव हो गया था। साथ ही पथ के विभिन्न स्थानों पर stone metal WBM Gr-III, Surface Dressing एवं फ्लैक भी काफी क्षतिग्रस्त हो गया है। विभागीय निर्देशानुसार पथ को यातायात योग्य बनाने हेतु पथ के कटाव वाले स्थान पर Brick Bats भर दिया गया। वर्तमान में आवागमन चालू है। पथ को पूर्व की स्थिति में लाने हेतु पुनर्स्थापना का प्राक्कलन बनाया जा रहा है।

कार्यहित में आपातकालीन मरम्मत का प्राक्कलन की स्वीकृति अतिआवश्यक है।

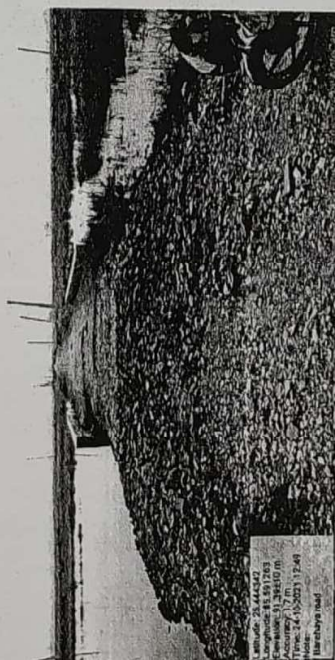
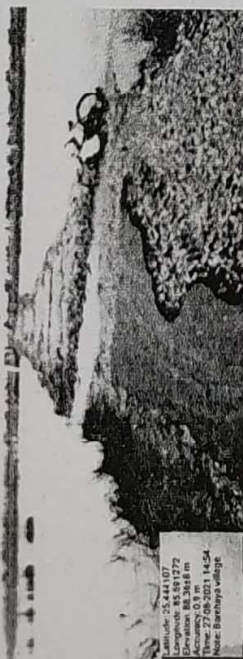
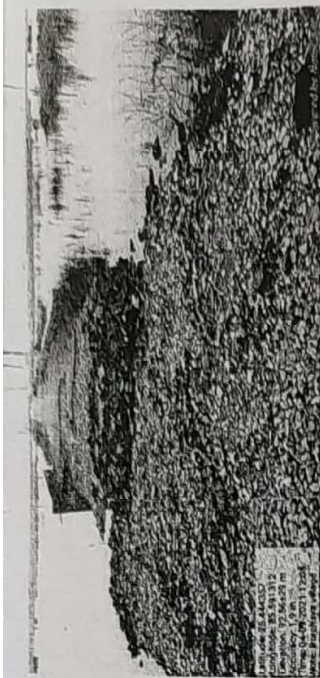

1. All works proposed for execution by contract will be notified in of from invitation to tender pasted on a board hung up in the office of and signed by the subdivision office Executive Engineer.

This notice will states the works to be carried out the hems and approximate quantity there of as well as the date for submitting and opening tender also the amount of earnest money to be deposited and the amount of the security deposit to be deposited by the successful tenderer and the percentage any to deposited from bills. Copies of the specifications, designs and drawings and any other documents required in connection with the submission of tender signed (for the purpose of identification by the Sub divisional/Officer/Executive Engineer during office hours.

2. In the event of the tender being submitted by firm it must be aligned separately by each member there or in the event of the absence of any partner, it must be signed on his behalf by a person holding as power-attorney authorising to do to.

3. Receipts for payments made on account of works when executed by a firm must also be signed by the several partners except where The contractors are described in the their as a firm with case she receipt must singed in the name of the firm be one of the partners, or by sold other person having authority to give effectual receipts of the firm.

4. The memorandum of work tendered for and the memorandum of materials to be supplied by the public work Department and their issue rates shall be filled and completed in the office of the sub divisional office Executive Engineer before the tender form is issued if a team is issues to an intending tender without having been 16 filled in and completed he shall request the office the have this done before he completes and delivers his tender.

8. The Engineer shall have the right of rejecting all or any of the tenders.

9. In the event of a tender being selected for acceptance the Engineer who opened the tender will be competent to accept the tender inform the tenderer of the selected tender who shall there upon sign copies of the specification and other documents mentioned in rule 1 and 4 for the purpose of identification and for his acceptance with the tender. The tenderer of the selected tender shall also deposit the required amount of the security money within the prescribed time if the tenderer fails to deposit the required amount of the security money within the prescribed time the Engineer may reject the tender.

If the Engineer is not competent to accept the tender himself he will inform the tenderer of the tender which he decides to recommend for acceptance, such tenderer shall there upon sign form with copies of the specification and other documents mentioned in rules 1 and 4 and shall deposit the required amount of the security money within the prescribed time. The tender with the specification and other documents signed by the tenderer will then be forwarded for acceptance to the Engineer who is competent to accept the same. If the said Engineer rejects the tender the security money deposited shall be refunded to the tenderer.

10. When a tender is selected for acceptance the tenderer shall deposit the required amount of the security money in cash the treasury and shall forward the challan to the Executive in government securities may be endorsed to the Executive Engineer in lieu of a cash deposit of the required amount of the security money has been deposited.

11. The amount of security money to be deposited is the tender whose tender is selected or acceptance shall be 10% of the estimated value of the work and towards the amount the earnest money already deposited by him shall be credited. At least half of this security inclusive of the earnest money shall be deposited by the tenderer within such time as may be notified to him in writing by the office opening the tender, failing which the tender shall be liable to rejection.

Any balance of the security money outstanding after completion of the contract with the tenderer may be made up by deductions of 5% of the amount of each payment to be made to him under clause 7 of the conditions of contract for work done under the contract.

12. When a tender has been selected for acceptance and the required amount of the security money has been deposited the Engineer shall scrutinise all page of the form of Item Rate Tender and Contractor for works to see the form has been properly filled up and signed by the contractor and the signature witnessed. CONDITIONS OF CONTRACT

Compensations

Clause 1 :- All compensation or other sums of money payable by the contractor to Government under the terms of his contract may be deducted from or paid by the sale of a which may be due or may become due to the contractor by Government on any account what so ever and in the event of his security deposit being reduced by reason of any such deduction or sale as aforesaid, the contractor shall within the days there after make good in cash or Government securities endorsed as aforesaid any sum or sums which may have been deducted from or arise by sale of his security deposit or any part there of.

The work should not be considered finished until such date as the Executive Engineer shall certify as the date on which the work is finished after necessary recitations of defects as pointed by the Executive Engineer or his authorised agents are fully complied with by the contractor to the Executive Engineer's satisfaction.

Clause 2 :- The time allowed for carrying out the work as entered in the tender shall be strictly observed by the contractor and shall be reckoned from the date on which the written order to commence work is given to the contractor. The work shall throughout the stipulated period of the contract be carried on with all due diligence (time being deemed to be the essence of the contract on the part of the contractor) and the contractor shall pay as compensation an amount equal to percent on the amount of the estimated cost of the whole work as shown by the tender for every day that the work remain uncommenced or unfinished after the proper dates bound in all cases in which the time allowed for any work exceeds one month to complete one fourth of the whole of the work before one half of such time elapsed and three fourths of the work before three fourths of such time has elapsed. In the event of the contractor failing to comply with this condition, he shall be liable to pay as compensation an amount equal to ½ percent, on he said estimated cost of the whole work for every day that the due quantity work remains incomplete. Provided always that the entire amount of compensation to be paid under the provisions this clause shall not exceed 10 percent on the estimated cost of the work as shown in the tender.

Clause 3 :- In any case in which under any clauses or clause of this contract the contractor shall have rendered himself liable to pay compensation amounting to the whole of his security deposit have render himself liable pay compensation amounting to the whole of his security deposit in the hands of Government (Whether paid in one sum or deducted by instalments) the Executive Engineer on behalf of the Government of Bihar, shall have power to adopt any of the following courses, as he may deem best suited to the interests of Government.

Action when a whole security deposit is for fitted.

(a) To rescind the contract (of which rescission notice in writing to the contractor under the hand of the Executive Engineer shall be conclusive evidence) and in which case the security deposit of the contractor shall stand for fitted and be absolutely at the disposal of Government.

(b) To employ labour paid by the public works Department and to supply materials to carry out the work, or any part of the work debiting the contractor with the cost of the labour and the price of the materials (of the amount of which cost and price certificate of the Executive Engineer shall be final and conclusive against the contractor) and crediting him with the value of the work done in all respects in the same manner and at the same rates as if it had been carried out by the contractor under the terms of his contract the certificate of the executive engineer as to value of the work done shall final and conclusive against the contractor.
