1. In this Agreement, words and expression shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to, and they shall be deemed to form and be read and construed as part of this agreement.

4. All items of previous approved BOQ has taken in revised approved BOQ including revised items and quantity as per revised technical sanctioned estimate. Only revised approved BOQ of all items and quantity valid for this road.
5. The following documents shall be deemed to form and be read and constructed as part of this Agreement,
 - (i) Special Conditions of contract, General Conditions of Contract and other as remain same as per main agreement.
 - (ii) Specification;
 - (iii) Drawings;
 - (iv) Bill of quantities; and
 - (v) Any other documents listed in the Contract Data as forming part of the contract.
