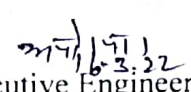
Kind of Checks exercised: -

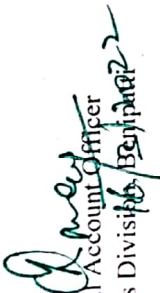

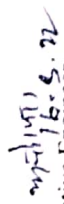
