Whereas the Employer is desirous that the Contractor execute Output and performance based Rural Road contract for the maintenance of Roads Islampur to Sahdeva Package No.- MR-N/21-22/Raxaul/04 (Tender ID-118562) (hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution of such Works and the remedying of any defects therein, at a contract price of Rs. 1,71,93,072.00 (Rupees One Crore Seventy-one Lakh ninety-three Thousand and seventy-two Only)

NOW THIS AGREEMENT WITNESSETH as follows:

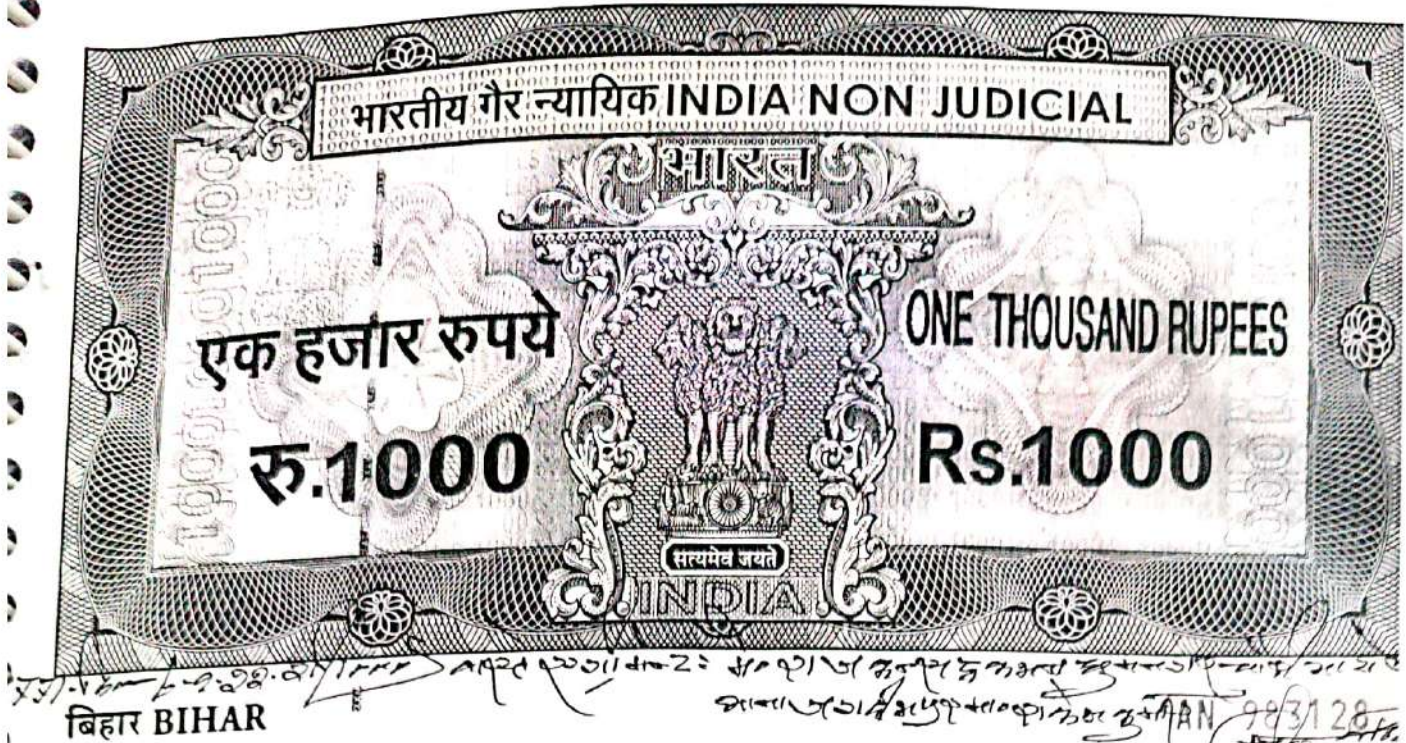

The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying the defects wherein the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
