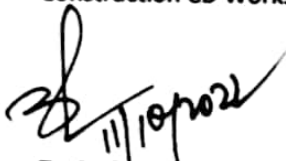

- All other codal formalities have been observed.

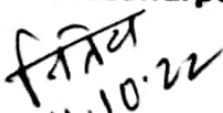
