

2. PIU's will must ensure three mandatory inspections within two months after payments.


3. The Total payment must not exceed the amount sanctioned.

4. Diversion of Allotment is Strictly Prohibited.


5. All concerned PIU's are directed to Submit Utilisation for this allotment Separately on GFR-12 B with road wise details as earliest in BRRDA.
