This agreement, made the 24 May 2023, Between EXECUTIVE ENGINEER, RURAL WORKS DEPARTMENT, WORKS DIVISION, RAXAUL [name and address of Employer] (hereinafter called "the Employer") of the one part, and RAJ CONSTRUCTION (PROPRIETOR-RAKESH KUMAR). Address- S/O RAMASHARAY PRASAD, P.O- DHUMNAGAR CHAURIYA TOLA, WARD NO-15, DHUMNAGAR, WEST CHAMPARAN, BIHAR- 845438 (BID ID-511056) [name and address of Contractor] (hereinafter called "the Contractor" of the other part). Whereas the Employer is desirous that the Contractor execute Output and performance based Rural Road contract for the maintenance of Roads Islampur to Sahdeva Package No.- MR-N/21-22/Raxaul/04 (Tender ID-118562) (hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution of such Works and the remedying of any defects therein, at a contract price of Rs. 1,80,97,756.00 (Rupees One Crore eighty Lakh ninety-seven Thousand seven hundreds and fifty-six Only)

NOW THIS AGREEMENT WITNESSETH as follows:

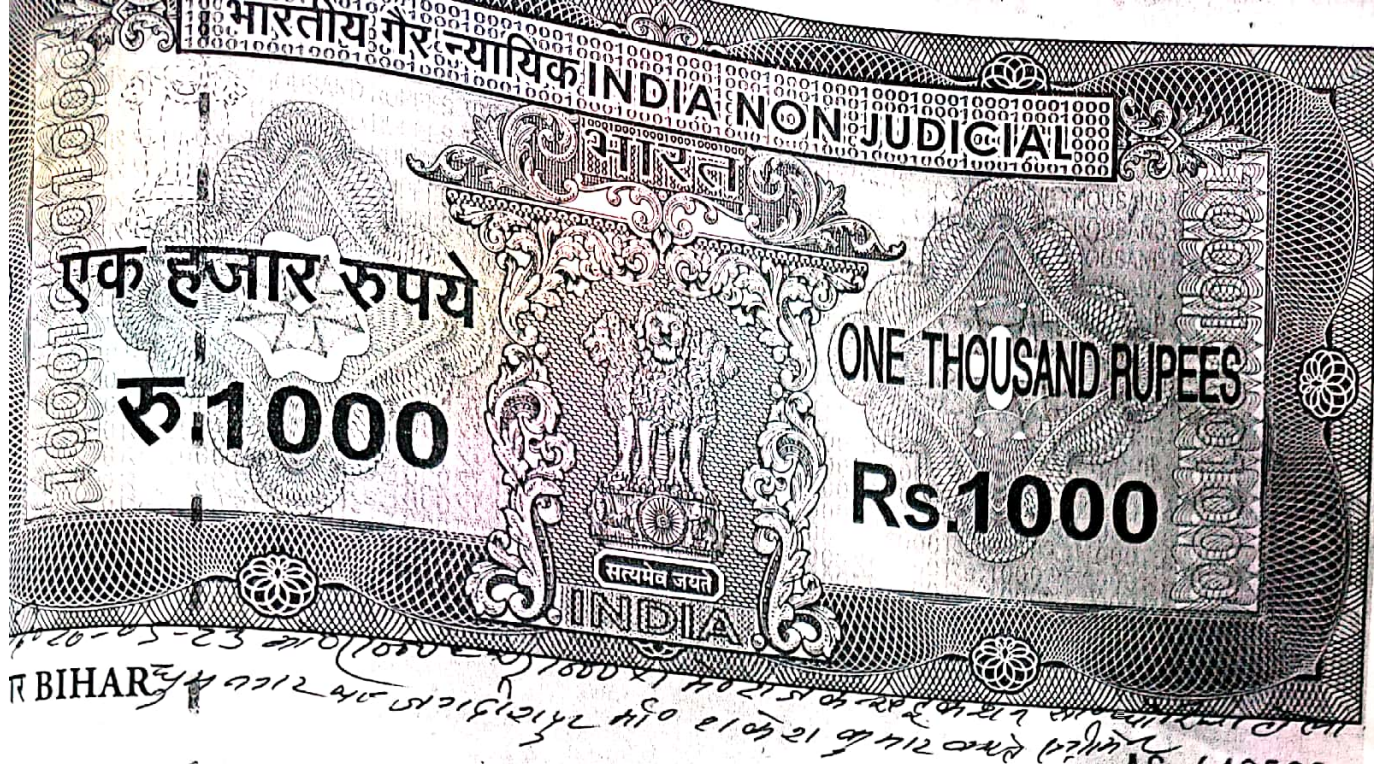

The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying the defects wherein the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
