Whereas the Employer is desirous that the Contractor execute output and performance based Rural Road contract for construction and maintenance of Road namely 1. Madheli Syphon To PMGSY Sadak via South Road, Length- 3.930 Km & 2. Maura Kharkaha Panchayat Sima To PMGSY Sadak via Inter College Road, Length- (Package No.-MR-N/2022-23 Madhepura/16); (Tender ID-124163) (Bid ID-538260) (hereinafter called ("The works")) and the Employer has accepted the Bid by the Contractor for the execution of such works and the remedying of any defects therein, at a contract price of Rs 1,66,06,281.00 (Rupees One Crore Sixty Six Lakhs Six Thousand Two Hundred Eighty One Only)

 - ix) Any other document listed in the Contract Data as forming part of the contract.




