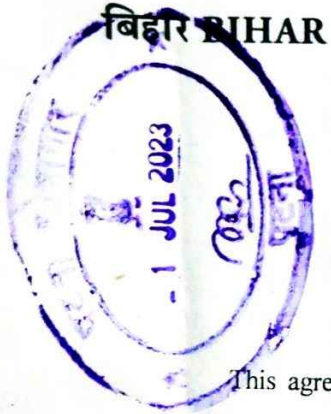

MBD Agreement
