This agreement, made the 18th day of Dec-2023 Between The Executive Engineer R.W.D.Works Division, Banka-II Bihar (here in after called "the Employee") of the one part, and Anil Kumar Singh, Village-Sadpur, Post- Maheshadih, Thana-Banka, Dist-Banka, Bihar (Bid ID-522465) (here in after called "the Contractor") of the other part, Whereas the employer was desirous that the contract or execute the Construction of Road from (i) Kotwali gopalpur Path To Govindpur Tak (ii) Nawada Goradih Path To Hortoda Tak (iii) T02 To Kharba Tak (MR-N/22-23 Banka-2/14) Year 2021-2022 under Head 3054 MR Yojna, (Tender ID-120980) Block-Rajoun, District-Banka, Bihar under Rural Works Department Govt. of Bihar, Chief Engineer -2 Patna Letter No.- 982 (Attach) Dated 03.04.2023 and the Employer had accepted the Bid by the contractor for the execution and completion of Such works and the Routine maintenance of works for Five Years of the Contract Price remedying of any defects therein, at Construction Cost Rs. 12472799.00 & Maintenance Cost Rs. 2855712.00 with a Total Amount of Rs. 1,53,28,511/- (Rupees One Crore Fifty Three Lacs Twenty Eight Thousand Five Hundred Eleven Only) at bidder rate quoted 13.25% (Thirteen point Twenty Five Percent) below the estimated Cost. Now that (due to revision of G.S.T. rate from 12% to 18%) the original agreement with all details and terms and conditions is being revised, vide S.E. Bhagalpur circle Letter No.-1295 (encl) dated 08.12.2023, with Revised Rs. 15916547/- (Rs. One Crore Fifty Nine Lakh Sixteen Thousand Five Hundred Forty Seven only), Hence the net increase in cost due to revised agreement is Rs. 588036/- (Rs. Five Lackh Eighty Eight Thousand Thirty Six only) which constitute the agreement value of this revised agreement. All the conditions of original Agreement will remain unchanged and will be in force with this revised agreement. The revised B.O.Q. will make the part of this agreement.
