Whereas the Employer is desirous that the Contractor execute Construction of Road & CD Works with Maintenance from Group No.- MR-N/23-24 Chakia/01, (SH-74 Diliya Bazar to Bathna, L031-R.E.O Road To Pandey Tola, Kesariya Mathiya To Bankat Maffi Road, S.N 54 (SH.74) To Lalbaniya & L023-R.E.O ROAD TO LALBABU RAY TOLA (VR5)) Tak Path Nirman. Road under MR (3054) New Maint. Policy-2018 and thereafter undertake routine maintenance for five years; and the Employer has accepted the Bid by the Contractor for the execution and completion of such Works and the remedying of any defects and routine maintenance therein at a cost of Rs.40477527=00 Rupees-(Four core four Lakh seventy seven thousand five hundred twenty seven) only.

NOW THIS AGREEMENT WITNESSETH as follows:-

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to, and they shall be deemed to form and be read and construed as part of this Agreement.

In Consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all aspects with the provisions of the Contract and undertaking routine maintenance for five years.
