

WHEREAS the Employer desires that the Works known as Construction and Maintenance of Road namely Package No.-MMGSY-WB-18-MADHEPURA-01 (Tender ID\_ 2020\_ECBIH\_96659\_1, Bid ID- 417765) [name of the Contract] should be executed by the Contractor, and has accepted a Bid by the Contractor for the execution and completion of these Works and the remedying of any defects therein, Contract Price of Construction Cost Rs. 4,50,77431.00 + Maint. Cost Rs. 46,17,505.00= 4,96,94,936.00 (Four Crore Ninety Six Lakh Ninety Four Thousand Nine Hundred Thirty Six) only

- (i) Construction Program, Methodology, Quality Assurance Program and Environmental Management Plan
- (j) Joint Venture Agreement [for JVs only]
- (k) Any other document listed in PCC as forming part of the Contract

3. In consideration of the payments to be made by the Employer to the Contractor as indicated in this Agreement, the Contractor hereby covenants with the Employer to execute the Works and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
