This agreement, made the 05th day of January 2023, Between EXECUTIVE ENGINEER, RURAL WORKS DEPARTMENT, WORKS DIVISION, RAXAUL [name and address of Employer] (hereinafter called "the Employer") of the one part, and M/S Raghubans Singh Station Raod Belbanwa, P.O-Motihari, P.S.-Nagar Thana, East Champaran, Bihar-845401 (BID ID-511247) [name and address of Contractor] (hereinafter called " the Contractor " of the other part). Whereas the Employer is desirous that the Contractor execute Output and performance based Rural Road contract for the maintenance of Roads L029 Belwa to Netua Tola Bathani Tola Package No.-MR-N/21-22/Raxaul/06 (Tender ID-118564) (hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution of such Works and the remedying of any defects therein, at a contract price of Rs. 1,34,25,866.00 (Rupees One Crore thirty-four Lakh twenty-five Thousand eight Hundred and sixty-six Only)

NOW THIS AGREEMENT WITNESSETH as follows:-

1. In the Agreement, words and expression shall have same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to, and they shall be deemed to form and be read and construed as part of this Agreement.
2. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the works and remedy and defects therein in conformity in all aspects with provisions of the Contract.
3. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying the defects wherein the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
