

'NOW THIS AGREEMENT WITHNESSETH as follows :-

1. In this Agreement, Words and expression shall have the same meanings as are respectively assigned to them in the Condition of contract hereinafter referred to, and they shall be deemed to form and be read and construed as part of this Agreement.
