- 3) Form M & N with affidavit and clearance challan from Mining Department should be deposited.
- 4) Material Test report from concerned Govt. Department should be deposited by the contractor at his own cost and it should be satisfactory.
- 5) If defective materials are found at site, the contractor will be completely responsible for that.
- 6) The updated work programme shall be submitted at intervals of 30 days.
- 7) This agreement is valid subject to verifications of amount of security deposit, performance security amount/performance guarantees amount. If in process of verification, these amount in any form found false, the agreement will be cancelled automatically and further proper action will be taken as per govt. orders.
