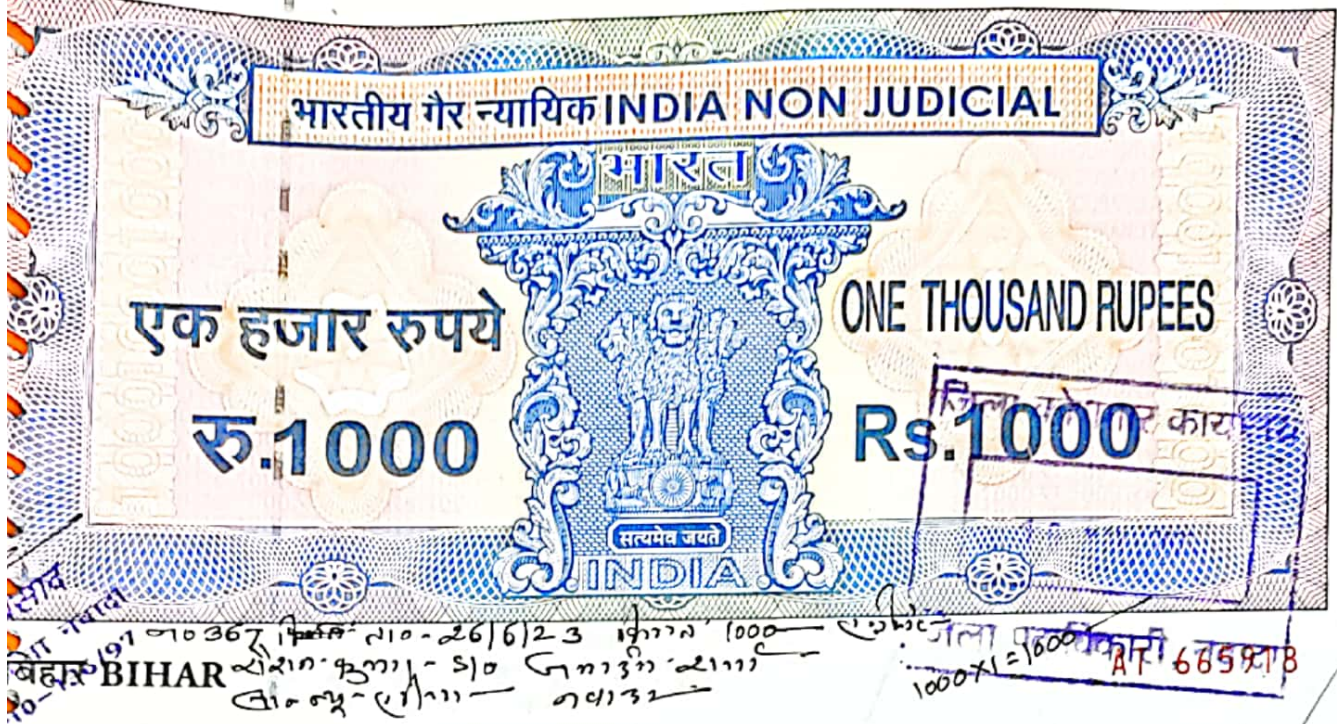




AGREEMENT FORM

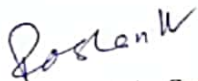
