Mob. No.9470236823 Whereas the Employer is desirous that the Contractor execute Construction of Road & CD Works with Maintenance, Group No.- MR-N/22-23 Chakia/02 के अधीन 1. Purvi champaran jila antargat mehshi prkhand ke rajepur bazar se slempur bazar tak REO tak एवं 2. Mehshi Kataha RWD Road Mandir to Purani Mehshi Tola. Road under New Maint. Policy-2018 MR (3054) and thereafter undertake routine maintenance for five years; and the Employer has accepted the Bid by the Contractor for the execution and completion of such Works and the remedying of any defects and routine maintenance therein at a Total Cost of Rs.[(Previous Agreement Value=31255555.00+1646311.00. (Balance Agreement Value)] = Total Revised Agreement Value Rs.32901866=00 Rupees-(Three core Twenty nine Lakh one thousand eight hundred sixty six) only.

NOW THIS REVISED AGREEMENT WITNESSETH as follows:-

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to, and they shall be deemed to form and be read and construed as part of this Agreement.
2. In Consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all aspects with the provisions of the Contract and undertaking routine maintenance for five years.

The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying the defects wherein and undertaking routine maintenance for five years, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
