and sixty-one Only)

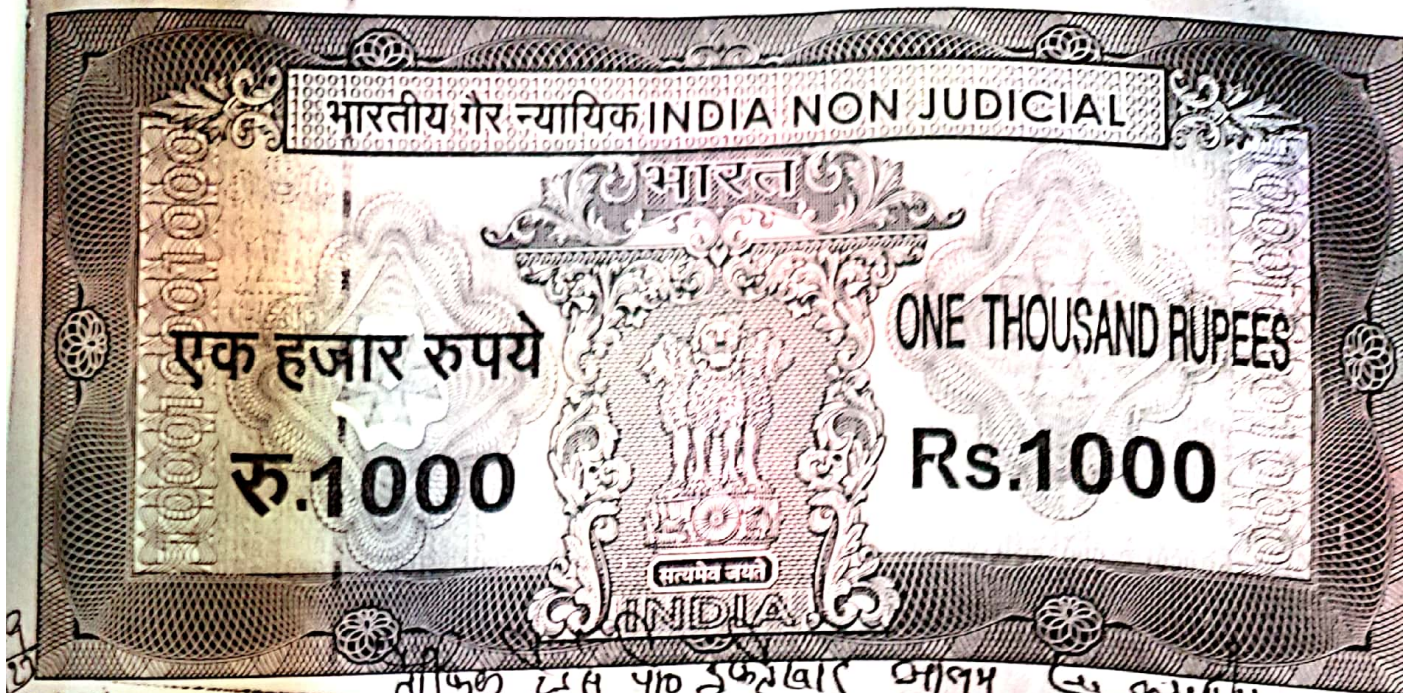
NOW THIS AGREEMENT WITNESSETH as follows:
