Revised MBD Agreement

This agreement, made the 15 day of **June 2023**, in continuation of **Agreement no.-25(MBD)/2022-23** between Executive Engineer, R.W.D.(W) Division, Sheikhpura cum PIU, BRRDA (hereinafter called "the Employer") of **Sri Birendra Kumar, At-Barsa, Post-Ghuskuri, Distt.-Sheikhpura (Bihar)**. (hereinafter called "the Contractor"). Whereas the Employer is desirous that the Contractor execute **Construction of Road and CD Works with maintenance for Dih Kusumbha To Rajauli** [name and identification number of Contract] (hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution and completion of such Works and routine maintenance of the works for 5 years and the remedying of any defects therein at a cost of Rupees **1,08,42,022/- (Rs. One Crore Eight Lacs Forty Two Thousand Twenty Two only) and Rs.35,44,505/- (Rs. Thirty Five Lacs Forty Four Thousand Five Hundred Five Only.)** as per revised BOQ approved by S.E., R.W.D. (W) Circle, Munger vide letter no.-611 (Encl). dt.13.06.2023 respectively.
