

- 5) If defective materials are found at site, the contractor will be completely responsible for that.
- 6) The updated work programme shall be submitted at intervals of 30 days.
- 7) This agreement is valid subject to verifications of amount of security deposit, performance security amount/performance guarantees amount. If in process of verification, these amount in

any form found false, the agreement will deeded to be cancelled automatically and further proper action will be taken as per govt. orders.
