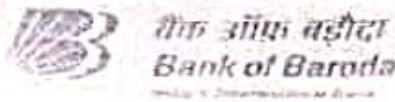

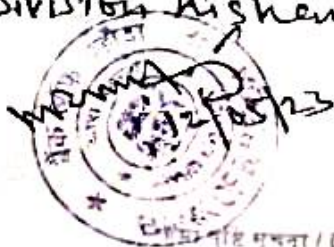
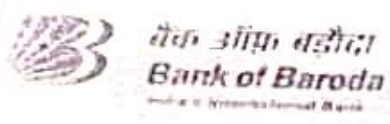

6. A Form 16G/15H/15AA if applicable has to be submitted by Resident individuals for each financial year, prior to crossing the threshold limit, failing which TDS will be deducted.
7. Form 15H can be accepted only from senior citizens (age of 60 years or more).
8. Premature Withdrawal Clause
9. Premature withdrawal of deposit less than Rs. 1 crore will attract 1% penalty i.e. 1% less than card rate as on the date of deposit for the period for which deposit has remained with Bank.
10. Premature withdrawal of deposit for Rs. 1 crore and above will attract 1.5% penalty i.e. 1.5% less than card rate as on the date of deposit for the period for which deposit has remained with Bank. For premature withdrawal of deposit Rs. 1 crore and above, a written intimation of minimum 31 days prior to withdrawal of deposit is to be given to Bank.
11. In case of NON-CALLABLE DEPOSIT - Premature withdrawal not allowed.
