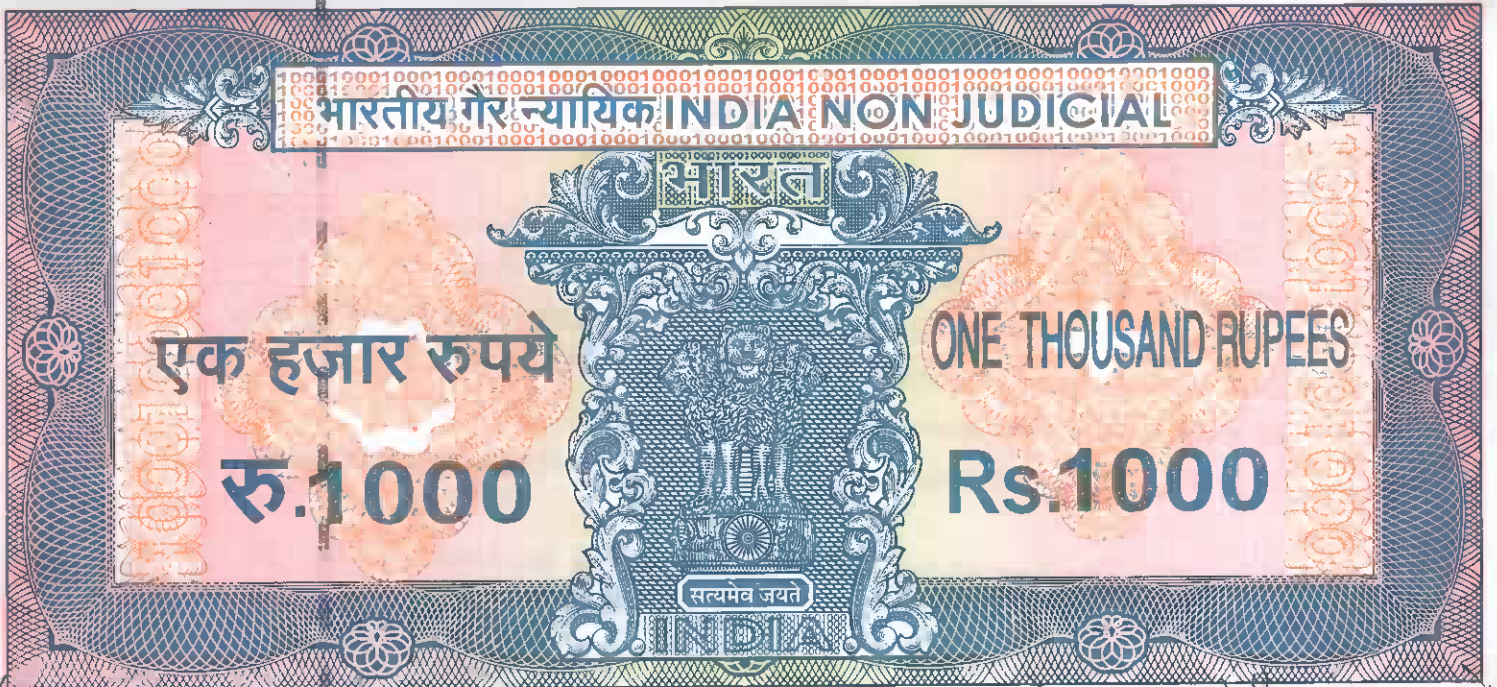

Revised MBD Agreement

This agreement, made the ____ day of September 2023, in continuation of Agreement no.- 20(MBD)/2021-22 between Executive Engineer, R.W.D.(W) Division, Sheikhpura cum PIU, BRRDA (hereinafter called "the Employer") of Sri Anand Kumar, S/o. Sri Anil Kumar Singh, Village+Post- Mafo, Near Shiv Mandir, P.S.-Mehus, Distt.-Sheikhpura (Bihar). (hereinafter called "the Contractor"). Whereas the Employer is desirous that the Contractor execute Construction of Road and CD Works with maintenance for (A) Sheikhpura Sumka Path To Chakavgil Path (B) Sheikhpura Kusumbha PWD Road Manipur Aima Via Aifni (Tender Group No.-MR-N/19-20, Sheikhpura-06). [name and identification number of Contract] (hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution and completion of such Works and routine maintenance of the works for 5 years and the remedying of any defects therein at a cost of Rupees 1,52,57,439/- (Rs.
