One lakh eighty thousand Only) and this guarantee is valid up to 9-04-2024 and we shall be released and discharged from all liabilities hereunder unless a written claim for payment under this guarantee lodged on us within 0 months from the date of expiry of this guarantee i. e. on or before 09-04-2024 irrespective of whether or not the original guarantee is returned to us.
