

GUARANTEE BOND

In consideration of the President of India (hereinafter called "the Government") having agreed to exempt Yogendra Kumar (hereinafter called "the said Contractor(s)") from the demand, under the terms and conditions of an Agreement dated _____ made between M/S M. G. Constructions and The Executive Engineer, R.W.D. (W) Division, Gaya

for Contract of Construction work **MR-N-22-23 Gaya/01** (hereinafter called "the said Agreement"), of security deposit for the due fulfilment by the said Contractor(s) of the terms and conditions contained in the said Agreement, on production of a Bank guarantee for Rs 1663000/- (Rs Sixteen Lakh Sixty Three Thousand Thousand only) , We, Dakshin Bihar Gramin Bank Jahanabad (hereinafter referred to as "the Bank") at the request of M/S M. G. Constructions, Contractor(s) do hereby undertake to pay to the Government an amount not exceeding Rs 1663000/- (Rs Sixteen Lakh Sixty Three Thousand only) against any loss or damage caused to or suffered by or would be caused to or suffered by the Government by reason of any breach by the said Contractor (s) of any of the terms or conditions contained in the said Agreement.

2. We, Dakshin Bihar Gramin Bank, do hereby undertake to pay the amounts due and payable under this guarantee without any demur, merely on a demand from the Government stating that the amount claimed is due by way of loss or damage caused to or would be caused to or suffered by the Government by reason of breach by the said Contractor(s) of any of the terms or conditions contained in the said Agreement or by reason of the Contractor(s) failure to perform the said Agreement. Any such demand made on the Bank shall be conclusive as regards the amount due and payable by the Bank under this guarantee. However, our liability under this guarantee shall be restricted to an amount not exceeding Rs 1663000/- (Rs Sixteen Lakh Sixty Three Thousand only) ;

3. We, Dakshin Bihar Gramin Bank, undertake to pay to the Government any money so demanded notwithstanding any dispute or disputes raised by the Contractor(s)/supplier(s) in any suit or proceeding pending before any Court or Tribunal relating thereto, our liability under this present being absolute and unequivocal

4. We, Dakshin Bihar Gramin Bank, further agree that the guarantee herein contained shall remain in full force and effect during the period that would be taken for the performance of the said Agreement and that it shall continue to be enforceable till all the dues of the Government under or by virtue of the said Agreement have been fully paid and its claims satisfied or discharged or till **The Executive Engineer, R.W.D. (W) Division, Gaya Office/Deptt./Ministry of Bihar** certifies that the terms and conditions of the said Agreement have been fully and properly carried-out by the said Contractor(s) and accordingly, discharges this guarantee.

5. We, Dakshin Bihar Gramin Bank, further agree with the Government that the Government shall have the fullest liberty without our consent and without affecting in any manner our obligations hereunder to vary any of the terms and conditions of the said Agreement or to extend time of performance by the said Contractor(s) from time to time or to postpone for any time or from time to time any of the powers exercisable by the Government against the said Contractor(s) and to forbear or enforce any of the terms and conditions relating to the said Agreement and we shall not be relieved from our liability by reason of any such variation, or extension being granted to the said Contractor(s) or for any forbearance, act or omission on the part of the Government or any indulgence by the Government to the said Contractor(s) or by any such matter or thing whatsoever which under the law relating to sureties would, but for this provision, have effect of so relieving us.
