NOW THIS AGREEMENT WITNESSTH as follow :

1. In this Agreement, Words and expressions shall have the same meanings as are respectively assigned to them in the general conditions hereafter referred to, any they shall be deemed to form and be read and construed as part of this Agreement.
2. In consideration of the payment to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the works and remedy any defects therein conformity in all aspects with the provisions of the Contract.
3. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the works and the remedying the defects wherein the contract price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract
4. The following documents shall be deemed to form and be read and constructed as part of this Agreement, viz :
 - i. Letter of Acceptance
 - ii. Contractor's Bid;
 - iii. Section VI- General Conditions;
 - iv. Section VII- Particular Conditions;
 - v. Section V- Technical Specifications (General and Supplementary Technical Specifications);
 - vi. Appendix A-Drawings
 - vii. Section IV- Works Schedule
 - viii. Quality Plan for Output and Performance Based Road Contract as per Clause A14.1 of the Technical Specifications
 - ix. Appendices to the contract
 - x. Addenda issued during bid period
 - xi. Any other relevant documents Listed in the particular conditions together with any post bid correspondence.

In witness whereof the parties thereto have caused this agreement to be executed the day and year first before written.

Special Conditions of Contract.

Along with conditions given in the agreement form, all other conditions like conditions of N.I.T. & its enclosures, conditions of tender decision order, condition of Administrative sanction, conditions of technical sanction, the instruction issued from time to time by the Govt. officials in any form will be applicable.

- 1) Hire charge of departmentally supplied Road Roller in any will be recovered on the rate applicable.
- 2) Cost of Empty bitumen drums will be recovered on the rate applicable.
- 3) Form M & N with affidavit and clearance challan from Mining Department should be deposited.
- 4) Material Test report from concerned Govt. Department should be deposited by the contractor at his own cost and it should be satisfactory.
- 5) If defective materials are found at site, the contractor will be completely responsible for that.
- 6) The updated work programme shall be submitted at intervals of 30 days.
- 7) This agreement is valid subject to verifications of amount of security deposit, performance security amount/performance guarantees amount. If in process of verification, these amount in any form found false, the agreement will decided to be cancelled automatically and further proper action will be taken as per govt. orders.
