No.9431434918** Whereas the Employer is desirous that the Contractor execute **Construction of Road & CD Works with Maintenance from Group No.-MR-N/23-24 Chakia/02, (1.REO Road to Tajpur Patkheliya, 2.L033-REO ROAD TO KHAGOPALPUR (VR20) & 3.T01 To Gochchi Tola) Tak Path Nirman. Road under MR (3054) New Maint. Policy-2018** and thereafter undertake routine maintenance for five years; and the Employer has accepted the Bid by the Contractor for the execution and completion of such Works and the remedying of any defects and routine maintenance therein at a cost of **Rs.21688550=00 Rupees-(Two crore sixteen Lakh eighty eight thousand five hundred fifty) only.**
