Revised Agreement

(hereinafter called "the Contractor"). Whereas the Employer is desirous that the Contractor execute Construction & Maintenance of Road and CD work from Dih Kusumbha To Dih Kusumbha Yadav Tola. Under Head-M.M.G.S.Y. (S.C.) [name and identification number of Contract] (hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution and completion of such Works and routine maintenance of the works for 5 years and the remedying of any defects therein at a cost of Rupees 48,87,893/- eight Eighty seven Eight Ninety three (Rs. Forty Nine Lacs Forty Three Thousand Two Hundred Sixty Seven Only) and Rs.7,33,553/- (Rs. Seven Lacs Thirty Three Thousand Five Hundred Fifty Three Only) as per revised BOQ approved by S.E., R.W.D. (W) Circle, Munger vide letter no.-109 (Encl). dt.25.01.2024 respectively.
