(2) If the Bidder having been notified to the acceptance of his bid by the Employer during the period of Bid validity :

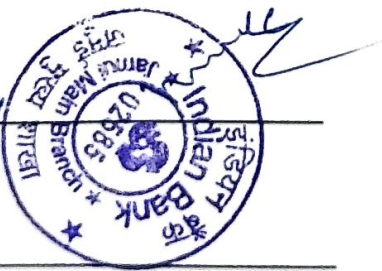
- (a) fails or refuses to execute the Form of Agreement in accordance with the Instructions to Bidders, if required; or

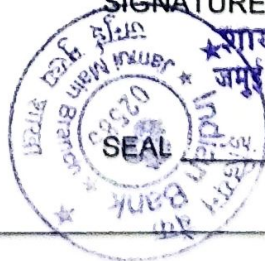
