3. We undertake to pay to the Government any money so demanded not-withstanding any dispute or disputes raised by the contractor(s)/Supplier(s) in any suit or proceeding pending before any court of Tribunal relating thereto our liability under this present being absolute and unequivocal.

The payment so made by us under this bond shall be valid discharge of our liability for payment there under and the contractor(s)/supplier(s) shall have no claim against us for making such payment.

- 4. We <u>Central Bank of India, Tajpur</u> (Indicate the name of Bank) further agree that the guarantee herein contained shall remain in full force and effect during the period that would be taken for the performance of the said Agreement and that it shall continue to be enforceable till all the dues of the Government under of by virtue of the said Agreement have been fully paid and its claims satisfied or discharged or till <u>18.06.2025</u> office of <u>Executive Engineer</u>, <u>Rural Works Department</u>, <u>Works Division</u>, <u>Teghra</u> certifies that the terms and conditions of the said Agreement have been fully and properly carried out by the said contractor(s) and accordingly discharges this guarantee. Unless a demand or claim under this guarantee is made us in writing on or before the <u>19.06.2025</u> we shall be discharged from all liability under this guarantee thereafter.
- 5. We central Bank of India, Tajpur (indicate the name of the Bank) further agree with the Government that the Government shall have fullest liberty without our consent and without affecting in any manner our obligation hereunder to vary of the terms and conditions of the said Agreement or to Extend time of performance by the said contractor(s) from time to time or to postpone for any time or from time of the powers excisable by the Government against the said contractor(s) and to forbear or enforce any of the terms and conditions relating to the said Agreement and we shall not be relieved from our liability be reason of any such variation, or extension being granted to the said contractor(s) or for any forbearance, act or omission on the part of the Government or any indulgence by the Government to said contractor(s) or by any such matter or thing whatsoever which under the law relating to sureties would, but for provision, have effect of so relieving us.
- 5. The guarantee will not be discharged due to the change in the constitution of the Bank or the contractor(s)/supplier(s).

We Central Bank of India, Tajpur (Indicate the name of the Bank) lastly undertake not to revoke this guarantee during its currency except with the previous consent of the Government in writing.
