SECTION 1

1. The Bidder may submit bids for any number of the work Packages. Bidders are advised to note the minimum qualification criteria specified in Clause 4 of the Instructions to bidders to qualify for the award of the contract and also inspect the site before bidding.
2. Time allowed for completion of each package is 12 months, including rainy season. If the construction cost of the package is greater than 10 Crore then Construction / Time of completion shall be enhanced from 12 Months to 18 Months.
3. The bids shall remain valid for acceptance for a period of 90(ninety) days from the last date of submission of bids. Bids once submitted cannot be withdrawn. If any bidder/tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
4. A set of bidding documents will be available online on website <http://pmgsytendersbih.gov.in>. Cost of bid document as per the amount specified in the Appendix to ITB non-refundable will be deposited online.
5. Bids must be submitted on-line on website <http://pmgsytendersbih.gov.in>
6. Bids submitted on-line must be accompanied with scanned copy of Affidavit.
7. If the Performance Security, security deposit and advance payment against BG is offered in the form of a bank guarantee, then it shall be accepted in form of only e-Bank Guarantee from a commercial bank.
8. Each bidder is required to furnish an affidavit giving information on prescribed Performa Section-3 Qualification Information of the Bidders required for evaluation of the bidding capacity of the bidder. Scanned cop of this affidavit shall be submitted on-line as part of Contractor's document.
9. The date and time of opening of the financial bid shall be notified on website <http://pmgsytendersbih.gov.in>. This is conveyed to the bidder automatically through an e-mail message. The Financial bids shall be opened accordingly on-line on the same website <http://pmgsytendersbih.gov.in> at the office of Secretary, Bihar Rural Roads Development Agency (BRRDA), Patna by the designated officers. All communication with the bidder will be done through e-mail message.
10. A bidder will not be permitted to bid for works in the Circle responsible for awarded an execution of contracts in which his or his spouse's near relatives (defined as first blood relations, and their spouses) is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive)
11. No Engineer of Gazetted rank or other gazetted officer employed in Engineering or Administrative duties in an Engineering Department as mentioned in Appendix to ITB is not allowed to work as a Contractor for a period of two years after his retirement from Government service, without Government permission. This contract is liable to be cancelled if either the Contractor or any of his employees is found to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the Contractor's service.
12. Bid documents and other details consisting of qualification information and eligibility criterion of bidders, plans, specifications, drawings, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be compiled with by the contractor can be seen in the office of the Executive Engineer mentioned in column 11 of the table corresponding to the respective package. All these documents can be downloaded from the website <http://pmgsytendersbih.gov.in> directly.
13. Other details can be seen in the bidding documents.
14. Qualified bidders have to be registered with RWD (if not already registered) before signing of agreement.
15. The undersigned has right to extend or cancel the tender without assigning any reason.
16. All Documents Submitted by the Bidders with affidavit shall be considered in technical bid evaluation but after award all the documents shall be duly verified.
17. As per clause 4.4 C of SBD Bidder who have taken part in more than 01 bid should mention the priority of the works in which they have taken part.
18. Contractor has to fill up all clauses as per section-3 of SBD pertaining to "Form of Qualification Information". The Contractor has to submit an additional affidavit regarding correctness of data in section-3 of SBD, in addition to all other required records as listed.
19. If any information submitted by contractor is found to be wrong at any stage then necessary action will be initiated under relevant clauses of "Bihar Thekedar Niamawali" and an FIR will also be lodged to initiate legal action against him.
20. Following points are to be followed for bridges:-
 - i. Pile integrity test is required for ensuring the quality of concrete cast during execution and forms part of Quality Assurance by the contractor. Thus, the cost towards this end need to be included in the bid.
 - ii. Acceptance load test on one span before opening to traffic to observe the overall behavior of the structure is required.
21. Character Certificate issued as per letter no.-29 dt.-25.01.2021 of Home Department, Govt. of Bihar and letter no.-489 encl. dt.-28.01.2021 of Rural Works Department, Govt. of Bihar is mandatory.
22. In view of the order passed on 06.07.2023 by the Hon'ble Patna High Court, Patna in CWJC No. - 9941/2022, the departmental letter no. 292(WE) dated 17-01-2020 will be applicable i.e. the threshold limit (below 10%) is abolished and for tender in which rate quoted is below than Bill of Quantity (BOQ) rate, additional performance guarantee is required as per RWD letter no. 852 dated 30.03.2022.
