REVISED AGREEMENT

This agreement, made the 19th day of July 2024 Between The Executive Engineer R.W.D. Works Division, Banka-II Bihar (here in after called "the Employee") of the one part, and Puspendra Kumar Singh, At+ P.O.+P.S.-Malaypur, Dist-Jamui, Pin - 811313 Bihar. (Bid ID-510287) (here in after called "the Contractor" of the other part. Whereas the employer was desirous that the contract or execute the Construction of Road from Kharhara Vijayhat RWD Path To Simariya Gajhanda Tak (MR-N/22-23 Banka-2/12) Year 2021-2022 under Head 3054 MR Yojna, (Tender ID-118399) Block-Barahat, District-Banka, Bihar under Rural Works Department Govt. of Bihar, Chief Engineer-2 Patna Letter No. 596 (Attach) Dated 25.06.2024 and the Employer had accepted the Bid by the contractor for the execution and completion of Such works and the Routine maintenance of works for Five Years of the Contract Price remedying of any defects therein, at Construction Cost Rs. 9754199.00 & Maintenance Cost Rs. 2198358.00 with a Total Amount of Rs. 1,19,52,557.00 (Rupees One Crore Nineteen Laes Fifty Two Thousand Five Hundred Fifty Seven Only) at bidder rate quoted 5.66% (Five point Sixty Six Percent) below the estimated Cost. Now that (due to revision of G.S.T. rate from 12% to 18%) the original agreement with all details and terms and conditions is being revised, vide S.E. Bhagalpur circle Letter No.-596(encl) dated 25.06.2024. with Revised construction Cost. of Rs. 10268808.00 Maintenance cost of Rs. 2314863.00 and the total cost of the agreement is now Rs. 12583671.00 (Rs One Crore Twenty Five Laes Eighty three Thousand Six Hundred Seventy One only). Hence the net increase in cost due to revised agreement is Rs. 631116/- (Six Laes Thirty One Thousand One Hundred Sixteen only) which constitute the agreement value of this revised agreement. All the conditions of original Agreement will remain unchanged and will be in force with this revised agreement. The revised B.O.Q. will make the part of this agreement.
