
Notwithstanding anything contained herein

- (i) Our liability under this bank guarantee shall not exceed **Rs. 14,11,000/- (Rupees Fourteen Lakhs Eleven Thousand Only)**
- (ii) This bank guarantee shall be valid up-to **05-02-2025**.
- (iii) We are liable to pay the guaranteed amount or any part thereof under this bank guarantee only and only if a written claim or demand is served upon us on or before **05-03-2025** (Minimum claim period of 30 DAYS), failing which all your rights shall be extinguished and Bank shall be discharged from all liabilities thereunder, irrespective of return / non return of original Bank guarantee.
- (iv) Unless an action to enforce the claim under this guarantee is initiated within one year from the date of denial of invocation / rejection of claim by the bank, provided the invocation has been made within the validity/ claim period; all rights of the beneficiary shall be extinguished and bank shall be discharged from all liabilities hereunder."
