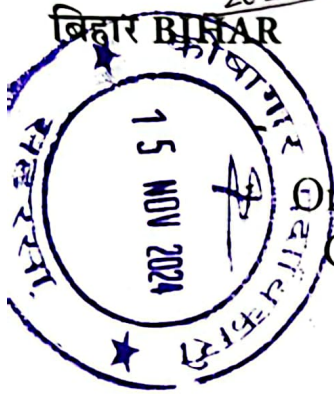

 - ix. Any other document listed in the contract data as forming part of the contract.
