General Rule and Directions for the guidance of Contractors

1. All works proposed for execution by contract will be notified in a form of invitation to tender pasted on a board hung up in the office of and signed by the Sub-divisional officer, Executive Engineer.

This notice will state the work to be carried out the items and approximate quantities thereof as well as the date for submitting and opening tenders also the amount of earnest money to be deposited and the amount of the security deposit to be deposited by the successful tenderer and the percentages. If any, to be deducted from bills. Copies of the specifications, designs and drawings, and any, other documents required in connection with the submission of tender signed for the purpose of identification by the Sub-divisional/Officer/Executive Engineer shall also be open for inspection by the contractor at the office of the Sub-divisional/Officer/Executive Engineer during Officer hours.

2. In the event of the tender being submitted by a firm, it must be signed separately by each member thereof, or, in the event of the absence of any partner, it must be signed on his behalf by a person holding as power-attorney authorising his to do so.

3. Receipts for payments made on account of work when executed by a firm must also be signed by the several partners except where the contractors are described in their tender as a firm in which case the receipt must be signed in the name of the firm by one of the partners, or by some other person having authority to give effectual receipts for the firm.

4. The memorandum of work tendered for, and the memorandum of materials to be supplied by the Public Work Department and their issue rates shall be filled in and completed in the office of the Sub-divisional Officer/Executive Engineer before the tender form is issued. If a form is issued to an intending tenderer without having been so filled in and completed, he shall request the office to have this done before he completes and delivers his tender.

Incomplete tender and tenders which propose ...any alteration in the work specified in the said form of invitation to tender, or, which contain any other conditions of any sort of omit the note the time within which the work can be finished, or which are not accompanied by a treasury challan for the required earnest money will be liable to rejection No. single tender shall include more than one work, but contractors who wish to tender for two or more works shall submit a separate tender for each. The tender shall bear the name of the work to which they refer written outside the envelope. Chas deposits for earnest money here in before maintained shall be made in Government Treasuries and the challan thereof should be enclosed with the tender.
