We hereby waive the necessity of your demanding the said debt from the Contractor before presenting us with the demand.

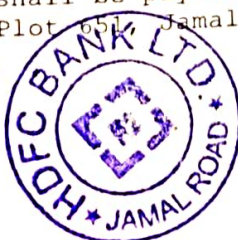


