- The Bidder may submit bids for any number of the work Packages. Bidders are advised to note the minimum 1. qualification criteria specified in Clause 4 of the Instructions to bidders to qualify for the award of the contract and also inspect the site before bidding,
- Time allowed for completion of each package is 12 months, including rainy season. If the construction cost of the package 2. is greater than 10 Crore then Construction / Time of completion shall be enhanced from 12 Months to 18 Months.
- 3. The bids shall remain valid for acceptance for a period of 90(ninety) days from the last date of submission of bids. Bids once submitted cannot be withdrawn. If any bidder/tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
