We further agree that no change or addition to or other modification of the terms of the contract or of the works to be performed there under or of any of the contract documents which may be made between you and the contractor shall in any way release us from any liability under this guarantee, and we hereby waive notice of any such change, addition or modification.

This guarantee shall be valid until 28 days from the date of expiry of the Defect Liability period.

Not with standing anything contained herein above our liability this guarantee is restricted to of **Rs.16,55,000/- (Rupees Sixteen Lakh Fifty Five thousand only)** and this guarantee is valid up to 19.02.2025 and we shall be released and discharged from all liabilities here under to unless a written request for payment under this guarantee is lodged on us on or before 19.02.2025 irrespective of whether the original guarantee is returned to us.
