This agreement, made the 22th day of 1297 -- 2024. between Rural Works Department (Govt.of Bihar) Works Division Simri Bakhtiyarpur (hereinafter called " the Employer") of the one part, and ENTERPRISES (Prop-Hari Shankar Jha). Add-Dumrail, Tiwari Tola. Ward No-23, Dist-Saharsa, Mob-9661350047 (Registration No.- 1220221, Class-I st) (hereinafter called "the contractor" of the other part) Whereas the employer is desirous that the Contractor execute the construction and maintenance of road from (1) PWD Road to Sarbela-GST Amount-1,06,166.00, (2) PWD Road to Mohanpur-GST Amount-5,78,091,00 (3) Saini Tola Via Lagjora Bandh to Goriyari Koshi Bandh 117 KM-GST Amount-3,81,624.00 (Package No- MR-N/19-20/Simri Bakhtiyarpur/09).
