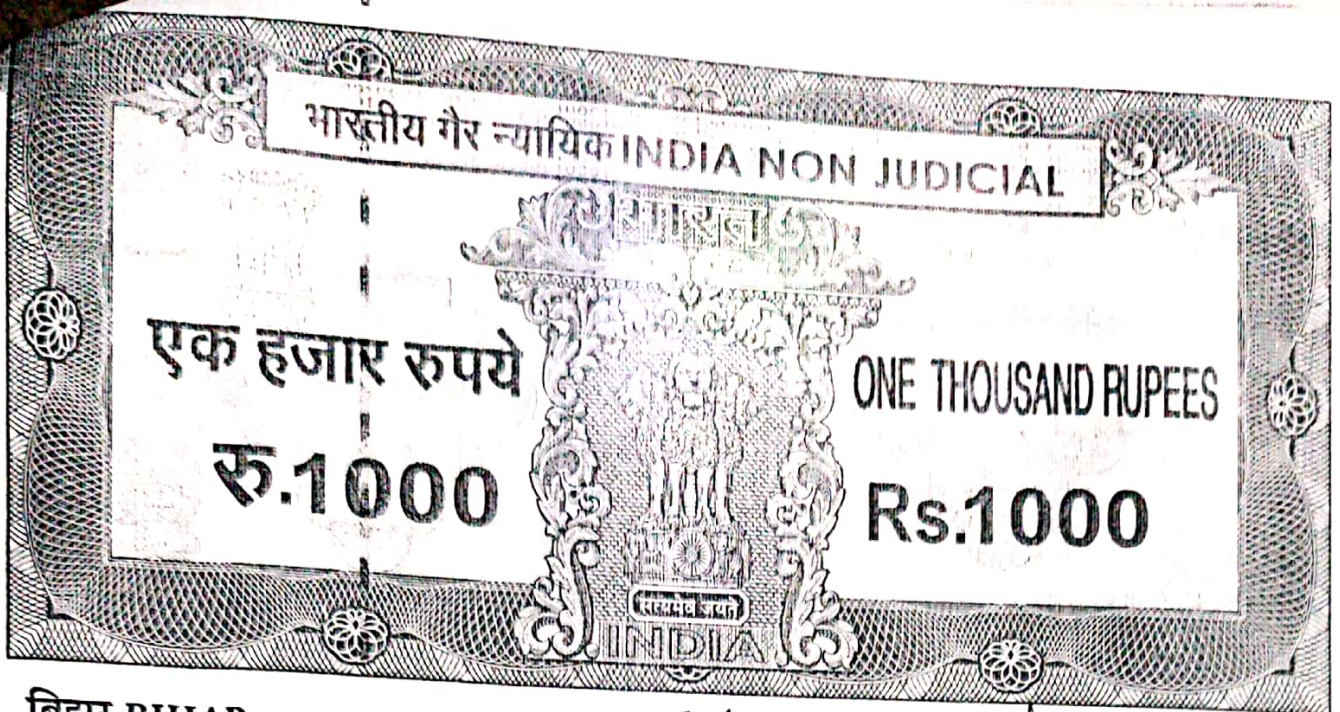

WHEREAS Barhonia Engicon Pvt. Ltd. H.O. Chandrakanta Complex, Rajeev Nagar, Road No. 14, Patna-24 (hereafter called "the Agency") has undertaken in pursuance of LOA No 1162, Dated: 05/10/2023 to execute "Maintenance of Road for Package No. MR-N/2022-23/Raxaul/C (Tender ID-122763) under Works Division, Raxaul" (hereafter called "the Contract")

Notwithstanding anything contained herein:

i.) The Bank's liability under this guarantee shall not exceed **Rs. 28,26,000.00 (Rupees Twenty Eight Lacs Twenty Six Thousand Only)**.

ii.) This guarantee shall be valid up to **20.08.2024** (Date of expiry of guarantee).

iii.) We are liable to pay the guaranteed amount or any part thereof under this Bank Guarantee only and only if you serve upon us a written claim or demand on or before **20.08.2025** (date of expiry of the Guarantee including claim period, if any).

iv.) Thereafter the Bank shall stand discharged from all its liability under this Guarantee and all your rights under this Guarantee shall stand extinguished, irrespective of the fact whether the Guarantee in original is returned back to us or not.
