The guarantee will not revoked during its currency without the prior consent of the beneficiary.

We hereby waive the necessity of your demanding the said debt from the contractor before presenting us with the demand.

We further agree that no change or addition to or other modification of the terms of the Contract or of the Works to be performed there under or of any of the Contract documents which may be made between you and the Contractor shall in any way release us from any liability under this guarantee, and we hereby waive notice of any such change, addition or modification.

This guarantee shall be valid Upto 20.07.2024 (a date 30 days after the lapse of Defect Liability Period).

"Not withstanding anything contained there in;

- i) Our liability under this Bank Guarantee shall not exceed **Rs. 24,31,000/-** (Rupees Thirty Four Lac Thirty Three Thousand Five Hundred Only)
- ii) This Bank Guarantee shall be valid upto 20.07.2024 and;
- iii) We are liable to pay the guarantee amount or any part, there of under this Bank Guarantee only if you serve upon us a written claim or demand on or before (date of expiry of Guarantee i.e. 20.07.2024).
